

I thought the one practice exam I took in this book was much more difficult than the real exam. I got 55% on the practice exam yet took and passed the real exam within about an hour. (In the interest of full disclosure I should say this was after switching to an online study aid that provided unlimited, simulated practice exams; and studying those for about a week...and I am an attorney with a firm grasp of contract law, real property and fiduciary duties.) To be fair, if you can master the exams in this book you will very likely master the real exam, but in my opinion it is more than you need to know if your goal is to simply pass, and it may be discouraging. For those reasons, I'd suggest one of the online study aids that provide simulated exams, instead. (Plus you will be taking the real exam on a computer so the online aids will familiarize you with the process.)

It's just a book of definitions, very upsetting because I figured there might have been some application. Having failed the test already I bought this book to help and the questions so far do not seem to be equivalent to the style the state uses. There are 3 practice exams and answers. I mean for the price it's a good tool but this book was not done with care, in the beginning there were plenty of mistakes and double prints.\*\*\*\*\*update\*\*\*\*Questions to answers do not match. The errors in this book are very high!!! And the math is not correct. Save your money don't buy.

Very helpful with all the vocabulary words and breakdown. the practice tests with the answers as to why the answer is correct to help remember when the subject is brought up.

You would be better off taking the exam with no preparation. I studied two separate courses and none of this was on the exam. Three people walking out of the testing stated the same thing. You'll study for hours only to not recognize any of the questions. Complete waste of time!! Good luck!
