

I'm an attorney in estate and business planning in the Twin Cities. I read an older edition, but believe there has been little change. I frequently recommend this book to clients, because becoming familiar with the issues helps clients decide what they want and helps them see why it's worth paying for legal advice to accomplish what they're after, whether that turns out to be the long-term preservation of a recreational property within the family, or a transfer at a future time, or a transfer in the near future. The book is readable, well-organized, and accurate. Those who criticize the book on the grounds that it is too expensive or not all they expected may have unreasonable expectations. A

book can't substitute for custom legal advice. However, I'm completely certain that reading this book saves my clients several hundred dollars in legal fees, just for the time they gain in being more efficient communicating with me about their projects. You may not feel like you can write your own member control agreement for your cabin when you're done, but you'll save money on conversations with the attorney you hire, and you'll understand better what you're doing, and you'll understand why it's better to hire an attorney than DIY--an effective use of \$20, in my book.

The bottom line is that the book introduces the concept pretty well.

Read this book before you pay a lawyer. THEN make sure your lawyer reads the book before you waste your money AND your relationships with any potential co-owners of a beloved family property. This book saved my family from a horrible pending leagal snarl which could have cost us thousands in dollars and untold emotional trauma to family relationships. Worth every penny. Everyone involved should own their own copy and highlight the parts that mean something to them. Then discuss, make a plan and THEN email it to your lawyer and all others concerned before you start paying the big bucks for the NECESSARY legalese!
